I understand:

- According to the Weatherford ISD policy for **grade-level acceleration**, a student must score **80%** or above on a criterion-referenced test in each of the following areas: language arts, mathematics, science, and social studies.
- According to the Weatherford ISD policy for **subject acceleration**, a student must score **80% or better on each semester test for a subject**, or, score an **80% or better when the two semester scores are averaged.**
- My child **must be available for testing** on the selected dates for credit by exam administration (choose one):
 - □ October 12-14, 2015
 - □ January 26-28, 2016
 - □ June 7-9, 2016
 - □ July 12-14, 2016

Upon successful completion of <u>Credit by Exam for Acceleration</u>, I understand:

- My child **must** accelerate to the next grade level or subject the next academic year. Should my child begin to struggle after attempting the next grade level or subject, a team consisting of the principal, teacher and parent/guardian will be assembled to determine the best placement for my child.
- The average of credit by exam results for grade or subject acceleration will be reported on the student's report card and transcript. Credit by exam scores are not included in grade point average computations.
- In the case of subject acceleration, my child is required to take the STAAR test at his/her grade level.
- Weatherford ISD is **not required** to provide transportation to or from another campus. I will be notified if there is any change in the current procedure.
- Elementary students who advance to the middle school level in a subject may miss opportunities in their regular classroom and/or school because of this acceleration.
- Weatherford ISD does not pay college tuition for students enrolling in college level courses who have accelerated beyond the curriculum offering.
